TERMS AND PAYMENTS

- The Buyer agrees to obtain from the breeder a Ragamuffin kitten.
- The Breeder is selling the above kitten gender, colour & price as selected above.

- The Buyer is giving a deposit of 75% or the full amount as invoiced by the breeder, only when kitten's have been born or selected from the available litter and the Buyer has selected their kitten via our website.
- The balance due is payable when the kitten turns 8 weeks old. The certificate is registered with CFA and received by the Breeder, the Breeder will complete the new owner information and send it to CFA. (The cost to courier/post documentation/certificates for your kitten is at buyer's cost).
- The Breeder will have the kitten registered with Cat Fanciers' Association and the new owner information will be uploaded to the system or any similar system when the kitten reaches the age of 8 weeks.
- The Buyer understands the deposit is REFUNDABLE (only if another buyer takes over the commitments to buy the kitten you paid the deposit for, any shortfalls if the kitten is sold cheaper because it is too old and cancellation was late will be to the buyer's cost) because it is a commitment to buy the cat. The Buyer will take ownership rights once the kitten is paid in full and that the full payment be made no later than one week of the kitten's expected release or delivery date with special written arrangements with the Breeder up to 8 weeks (kitten 8 weeks old). After that time, the Breeder may sell the cat to another buyer.
- The Buyer will pay a Reservation Fee of \$200 which is non-refundable, as proof of your unconditional commitment to our future litters.

- Our RagaMuffin kittens are more than just beautiful, they are bundles of pure affection, born and raised in our home with love, care, and endless attention.

HEALTH GUARANTEE

- The breeder certifies that, upon receipt, the kitten is in good health and has been microchipped and registered according to the accompanying health record as said by the Ragamuffin.
- The Buyer agrees to have the kitten examined by its veterinarian at its expense within 2 days from the date of purchase. If the veterinarian does not give the kitten a clean bill of health, the Buyer must notify the Breeder immediately. The Breeder reserves the right to have the kitten re-examined by its own veterinarian at its own cost.
- Any condition that is minor, correctable, or a breed-related minor condition is not covered, and no condition which could go away, or is considered to be a condition which a kitten will likely grow out of, is covered.
- If the kitten is then found not to be in good health, the Breeder will resume possession if this is agreeable to both parties. The Breeder does not accept responsibility for contagious diseases diagnosed after 2 days from the date of purchase.

BREEDING RESTRICTIONS

- All our kittens are sold as pets only and not for any breeding purposes unless the Breeder makes arrangements for a breeding between the Buyer & Breeder. LIMITED CFA registration.
- The purpose of limited registration is to encourage spaying/neutering and reduce the number of unwanted and unplanned kittens put to death every year in animal shelters and also to protect our ragamuffin line from backyard breeders, etc.

TRANSPORT OF PUPPY

- The Buyer will be responsible for any/all transportation costs should he/she not be able to collect the kitten from the Breeder's home.
- Should the Breeder have to make any transport arrangements, these monies should be paid into the Breeder's account before the kitten is transported.
- Although all possible care will be taken with the Kitten's transport, the Breeder cannot be held responsible for any accidents/death of the Kitten as a result thereof.

THE BUYER'S RESPONSIBILITY

- The Buyer agrees to take good care of this kitten, feed and house the cat properly, maintain shots, control in public and when on the premises of the cat's home.
- The cat's outdoor area will be fenced in and secure or acceptable provisions will be made to assure the cat is safe anytime he/she is outdoors.
- The Buyer agrees to give the cat proper physical and emotional care and welfare.
- The Buyer agrees to remove blankets when cat are unattended as they can find themselves entangled and could suffocate to death when they panic in such a situation.
- The death, injury, or loss of said cat due to theft, carelessness, recklessness, abuse, neglect, heat stroke, or accident will not entitle the buyer to any compensation from the breeder.
- This kitten is warranted only for the purpose of being a companion animal, not for any other purpose or reasons.
- No warranty is given to the buyer for any special purpose or function of this kitten.

- The contract is legal and may be enforced by legal means at the Buyer's expense.
- The care and feeding instructions will be given to you along with the shot records for this kitten.

ENTIRE AGREEMENT

- This contract represents the entire agreement between the parties.
- The Breeder and the Buyer have made no other agreements, promises, or representations, verbal or implied, unless specifically stated in this written agreement.
- The Breeder and the Buyer will each receive one copy of this agreement signed by the Buyer as agreed above in United State and accepted by the Breeder.
- This is the entire agreement between the parties and is valid and agreed upon by all the parties concerned.
